****Hereby declare that (must indicate one option):**

- I am a duly qualified voter who is currently registered to vote in the Town of Hanover.
- I am absent from the Town of Hanover where I am domiciled and will be until after the next election, or I am unable to register in person due to a disability, and request that the forms necessary for absentee voter registration be sent to me with the absentee ballot.

****I will be entitled to vote by absentee ballot at the election designated above because (must choose one):**

- I plan to be absent on the day of the election from the Town of Hanover where I am domiciled.
- I cannot appear at any time during polling hours at my polling place because an employment obligation requires me to remain physically at work, or to be in transit to or from work from 7:00 a.m. through 7:00 p.m.
- I am unable to vote in person due to a disability.
- I cannot appear in public on Election Day due to observance of a religious commitment.

*The absentee ballot forms you receive will require you to sign an affidavit confirming that you are entitled to vote by absentee ballot due to one of the reasons stated above. The Moderator is required to compare the signature on the affidavit to your signature on this form. The absentee ballot **will not be counted** if the affidavit and this form are missing signatures or if the signatures do not appear to have been signed by the same person (RSA 659:50).*

For this Primary Election the following information is important to determine which absentee ballot (Democratic or Republican) to send. (If you choose a party affiliation and are not registered for that party, you will receive a ballot for the party in which you are currently registered.)

- I am currently **Undeclared** as to party affiliation and wish to receive a **Democratic** Party Ballot. I understand that this declaration registers me with the Democratic Party.
